We lobby Congress to protect consumer access to natural products, fight legislation that threatens access to natural products, and introduce legislation that promotes unencumbered access both to these products, and importantly, to the science behind them.

ment watchdog, files comments on proposed rulings, and educates the public and press about the benefits of natural health products.

ANH–USA: Making a Real Difference

ANH–USA makes change and protects the natural products industry. The impact of our commitment is very real. Recent accomplishments include:

- Mobilizing our grassroots activists to send over 300,000 emails to public legislatures on important integrative health issues.
- Filing three lawsuits against the FDA in support of the natural products industry and their right to speak freely to consumers about the science behind their products.
- Putting an integrative practitioner on the Comparative Effectiveness Research (CER) panel.

- Modifying the Senate healthcare bill to ensure that the CER program always includes integrative medicine practitioners on the board and advisory panel. This marks the first inclusion of integrative medicine in any federal program and will provide integrative medicine a voice in determining important areas of research, such as the role of dietary supplements in prevention and treatment.
- Collecting over 50,000 signatures on our Reform the FDA petition.
- Modifying dangerous Codex language in the FDA Food Safety Modernization Act that would have negatively affected the supplements industry.
- Introducing the Free Speech about Science Act in the House of Representatives that will permit industry to cite peer-reviewed scientific research about the health benefits of products.
- Modifying regulations in Delaware and Michigan that would have limited the practice of nutrition to Registered Dieticians; they now include Certified Nutrition Specialists.
